

1. General information on Gabonese forests

- Area: 22 800 000 ha (FAO, 2014) (in Gabon the forest is owned by the State)
- Organization of the national forest estate (permanent forest estate of the State and the rural forest estate)
- Forest management (CFAD: Forest concessions under sustainable management, PFA: Associated Forest Permits, etc.)



2. Issues related to good forest governance in Gabon

- The potential of Gabonese forests is unknown.
- Lack of reliable data to improve forest policy.
- The process of controlling forest concessions had to be modernized

Request for Official Development Assistance from the Government of Japan


- Forest Conservation Program (JICS) (2010-2014)
- Supply of equipment and training
- Project of Enhancing National Forest Resources Inventory System Contributing to Sustainable Forest Management (JICA) (2012 - ongoing)

Gabon has a high cloud coverage. This complicates the development of a forest cover maps.









 - Institutional capacity building
 - > Sensitization of operators and populations to the implementation of the monitoring system
 - Restart of negotiations with the EU on VPA FLEGT
